### Important Note:-

- 1) If NRI/OCI/PIO/ Foreign National Candidate is desirous of seeking Admission in **Government and Aided College/Institute**, then he/she will have to fill the College/Institute preference On-line Option form (Part-II). Seat Allotment of NRI/OCI/PIO/ Foreign National Candidates for Government and Aided College/Institute will be carried out On-line through CAP.
- 2) NRI/OCI/PIO/ Foreign National Candidates are not required to fill the online College preference Option form if he/she is desirous of seeking Admission in **Un-Aided Colleges/Institute**. They will approach the Un-Aided Institutes/ Colleges for admission of their choice well before as per the time table displayed on the website. Such candidates are requested to fill the off line Application form of College/Institute of their choice for final admission at the time of Institutional Level Round. NRI/OCI/PIO/ Foreign National Candidates should get in touch with Un-Aided Colleges/Institutions for their admission. Seat Allotment for Un-Aided Colleges/

Institutes will be carried out by the Admission Committee of the respective College/Institute purely on the basis of Merit.
