4	Selected candidates to report to the respective institutes with all original documents and requisite fees for admission	21/11/2017 at 2.00 pm and completion of admission by 05.00 pm
5	Wait listed candidates from the wait list to report to the respective Institutes for admission against vacancy (if any)	22/11/2017 from 11.00 am and completion of admission by 05.00 pm
6	Cut-off date of MPTH course admission	22/11/2017

The selected candidates should join the respective college by paying requisite fees and submitting original documents in a prescribed time. **No extra time will be given.**

Eligibility for admission process:

- 1) All the candidates who are eligible as per PGP 2017 brochure for the State of Maharashtra.
- 2) Any candidate who is already admitted to MPTh course during previous rounds, and who has not filled the Status retention form, can also apply for this process. If such a candidate is selected in the process and desirous of joining the newly allotted college then previous college should return all Original Documents and Refund fee paid by the candidate. The candidate will have to pay Rs. 1500/- as administrative fee as per rules of PGP-CET 2017 Brochure.
- 3) The vacancy created by shifting, the previous college can fill the vacant seats by PGP-CET-2017 eligible candidates by 22/11/2017.
- 4) The Commissioner, State CET Cell will depute observer for supervision of entire admission process.
