#### **Directions I**

Mop Up I round for admission to Medical and Dental Post Graduate courses at Govt./ Corp/ Pvt. Unaided/Minority Medical/Dental Institutions was declared on 12/05/2018 and last date of joining is 15/05/2018 upto 5.00 PM. As per notice dated 05/05/2018, vacant seats of Pvt. Unaided/Minority Medical/Dental Institutions are to be surrendered to respective Institutions. Institution wise vacancy position of unfilled/non joined seats is being declared on the website of State CET Cell and DMER along with list of eligible candidates for Institution level round.

All these vacant seats of Unaided Private/Minority, Medical/Dental Colleges will be filled by respective Institutions at Institutional Level.

- Submission of application by candidate from wait list, to respective Institute in person, on plain paper with all the details of NEET PG/MDS 2018 and interested Post Graduate subject/s.
- Publication of single list of applicants as per merit indicating selected/wait list status of the candidate on college website and notice board.
- Selected candidate(s) to report respective Institute with all original documents and requisite fees for admission.
- The cut-off date for admission is 18/05/2018 up to 5.00 pm.
- The respective Institutions should submit subject wise list of admitted candidates to State CET Cell via mail to E-mail ID's viz. maharashtra.cetcell@gmail.com, dmercetcell@gmail.com and MCI/DCI, on 18/05/2018 up to 7.00 pm.

During Mop Up round I, Inter-Se for constitutionally reserved category seats was conducted, hence all the seats at Unaided Private/Minority, Medical/Dental Colleges

belongs to 'General Category'. At the time of admission, candidate should submit original documents and requisite fees in prescribed time, no extra time will be given.

### **Directions II**

Mop Up II round for admission to Medical/Dental Post Graduate courses at Govt./Corp. Medical/Dental Institutions.

Mop Up II for Govt./ Corp. Medical/Dental, Institutions will be declared on 16/05/2018. Candidates who are already joined at Private Unaided/Minority Medical/Dental Institutions, and selected at Govt./Corporation institutions during Mop Up II round, should cancel their admission from respective Institution, collect Original Documents and attend admission process at Grant Government Medical College, Byculla, Mumbai on the scheduled date i.e. 18<sup>th</sup> May, 2018. Private Institutions should relieved such candidates immediately. All such candidates are exempted from Penalty as per rule No. 21.5 of Information Brochure. Candidates who are already joined at Govt./ Corp. Medical/Dental Institutions, and selected at Govt./Corp Institutions during Mop Up II round, should directly report at Grant Government Medical College, Byculla, Mumbai. Candidates who have not been allotted any seat during previous round(s) and selected at Govt./Corp. Institutions during Mop Up II round, should directly report at Grant Government Medical College, Byculla, Mumbai along with all Original Documents and requisite fees.
