**ADMISSION NOTICE FOR MASTER IN HOTEL MANAGEMENT AND CATERING
TECHNOLOGY (M. HMCT) 2018-19**

Online Registration, Document Verification & Confirmation and Counselling Round

This admission notice is being issued for admissions to First Year of Full Time Post Graduate course in Hotel Management (M. HMCT) through counselling round in the Unaided Private Professional Educational Institution for the Academic Year 2018-19 in the Maharashtra State.

Aspiring candidates are informed to read the aforesaid Act and Rules published on <http://www.mahacet.org/MHMCT2018>.

Eligibility Criteria for various types of candidature for Admission:

Maharashtra State Candidates and All India Candidates

- i) The Candidate should be an Indian National;
- ii) Passed Bachelor Degree in Hotel Management and Catering Technology or its equivalent, with at least 50 % marks (at least 45% marks in case of candidates of Backward class categories and persons with disability belonging to Maharashtra State only); Candidates appeared Bachelor degree or equivalent in the relevant field of Engineering/Technology in 2018 should produce passing certificate by 10th of August 2018.
- iii) Obtained score in MAH- M. HMCT- CET2018.
Or
For sponsored candidates, minimum of two years of full time work experience in a registered firm/ company/ industry/ educational and/ or research institute/ any Government Department or Government Autonomous Organization in the relevant field in which admission is being sought. (The Sponsored Candidates Should have required Experience on 13th July 2018.)

Important Note:- Only those Candidates who have verified and confirmed documents at Maharashtra State Institute of Hotel Management & Catering Technology, 412-C, K. M. Munshi Road, Shivaji Nagar, Pune 411016 (Counselling Centre) and whose name appears in Final Merit List shall be eligible for admission for all types of seats/quota.

Important Instructions for candidate:

1. The admission process will be conducted through counselling round only in place of CAP round I.II & III due to less number of eligible candidates.
2. It is mandatory for candidates to remain present *in person* for the counselling round.
3. The Seat Acceptance Fee shall be Rs. 1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fees is to be paid at ARC through ONLINE MODE only.
4. If candidates fail to confirm online filled application form at **Counselling Centre**, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for CAP as well as **Institute Quota admissions**.
5. The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC and SBC categories should produce "Caste Validity Certificate (CVC)" issued by Scrutiny Committee of Social Welfare Department and the Candidate belonging to ST category should submit "Tribe Validity Certificate (TVC)" issued by Scrutiny Committee of Tribal Department. All Backward Class candidates excluding SC & ST should produce Non Creamy Layer certificate (NCL) **valid up to 31st March 2019** at the time of verification of documents at **Counselling Centre**. If Candidate does not possess CVC/TVC, NCL certificates, he/she can upload the receipt(s) of application made for obtaining CVC/TVC, NCL for claiming the category reservation. The certificate of CVC/TVC, NCL (as applicable) shall be produced on or before the date **(19/08/2018)** as declared by the ARA at ARC. If such candidates do not produce the certificates within the stipulated date, then the admission of such candidates will be cancelled.
6. Candidates who have registered as a reserved category candidate for MAH-M. HMCT-CET 2018 but unable to produce required documents for reservation claim during documents verification phase shall have to pay difference amount of fees of Rs. 200/- at the time of counselling through online mode.
7. **Candidates are advised to ensure before applying for the admission to the M. HMCT programme in a particular University that he/she is eligible for admission to the programme as per the relevant Eligibility Rules of that University.**
