PGP/PGO/PGASLP & MSc (P&O) CET - 2018
Procedure of MOP-UP Round

As per PGP/PGO/PGASLP & MSc (P&O) Information Brochure of preference form system, it was published that the MOP-UP Round selection list will be declared on 12.09.2018. The details of this MOP-UP round are as follows -

(A) Eligibility for MOP-UP Round -

1. All candidates admitted in 1st round, 2nd Round and secured the admission.
2. All the candidates who are wait listed and to whom choice was not available during 1st round, 2nd round.

(B) Candidates NOT ELIGIBLE for the MOP-UP round -

1. Those who have submitted Status Retention Form in 1st or 2nd round.
2. Those who were selected in 1st round but failed to take the admission.
3. Those who were selected in 1st round but cancelled the admission.
4. Those who were selected in 1st round but resigned the seat.
5. Those who were selected in 2nd round but failed to take the admission.
6. Those who were selected in 2nd round but cancelled the admission.
7. Those who were selected in 2nd round but resigned the seat.

(C) Procedure of MOP-UP Round -

1. The list of selected candidates of MPTH/MOTH/MASLP for MOP-UP I round will be declared on 12.09.2018 after 08.00 pm.
2. Last date of joining to the respective college for the MOP-UP round for MPTH, MOTH, MASLP is 18.09.2018 upto 3.00 pm (excluding holidays).
3. Seats remaining vacant of MPTH/MOTH/MASLP courses in Government/Corporation Colleges after MOP-UP round will be declared on website on 18.09.2018 after 8.00 pm
4. The seats remaining vacant in Private Unaided/Minority Colleges (MPH) will be surrendered to respective colleges on 18.09.2018 after 10.00 pm.
5. Declaration of selection list for MPTH/MOTH/MASLP vacant seats for MOP-UP II round (Only for Government/Corporation Colleges) is 19.09.2018.
6. Last date of joining for selected candidate of MPTH/MOTH/MASLP of round dated 19.09.2018 (Only for Government/Corporation Colleges) is 25.09.2018 upto 5.00 pm.
7. If seats in Government/Corporation Colleges remain vacant after this MOP-UP round the CET CELL may conduct another selection round on 26.09.2018 if required.

8. Last date to fill MPTH seats (only for Private Unaided/Minority Colleges) at institutional level is 30.09.2018.
9. Cut-off-date for admission to MPTH/MOTH/MASLP course is 30.09.2018.

(D) Instructions for the MOP-UP Round -

1. If a candidate is upgraded during any rounds for Government/Corporation Colleges from Private to Government (MPTH) then there will be no penalty clause applicable to him/her.
2. If a candidate has a selected status for MPTH course on 18.09.2018 in Government/Corporation Colleges, then his/her name will be deleted for the merit list. He/She will not be considered for admission process to be carried out for private unaided/Minority colleges at institute level rounds.
3. The Candidate having selected for MPTH in Government/Corporation Colleges in round to be declared on or after 19.09.2018 and 26.09.2018 must join the seat. If the candidate fails to join then he/she will be charged penalty of Rs. 1,00,000/- and will not be eligible for the admission process for next two years in all Health Science Courses.
4. The admission process for Private Colleges will be completed on 18.09.2018 and the vacant seats will be surrendered to the respective institutions on 18.09.2018 after 10.00 pm.

(E) Procedure for Institutional Round for MPTH courses -

1. Institutional Round is only for Private Unaided/Minority colleges and for seats remaining vacant after MOP-UP I round.
2. All the candidates having admitted status on or before 18.09.2018 are NOT ELIGIBLE for institutional round.
3. For institutional round eligible and interested candidates should approach to the Dean/Principal of the respective colleges within prescribed time and submit application in person. Such type of applications should not be submitted in the State CET CELL/DMER in person or email. Such type of applications submitted in State CET CELL/DMER will not be considered valid for any institutional level admission process.
4. At the time of admission during institutional round a candidate should submit all this original documents along with requisite fees during prescribed time limit.
5. All those candidates selected and joined during 1st round, 2nd round and MOP-UP(s) round in Government/Corporation/Government Aided/Private Unaided/Minority Colleges are NOT ELIGIBLE to participate institutional level round.
6. The list of eligible candidates for the institutional round will be published on the website on 18.09.2018.
7. The schedule for intuitional level round for Private Unaided/Minority Medical Colleges is as follows -

1.	The list of vacant seats college-wise will be displayed on website.	18.09.2018 after 10.00 pm
2.	Submission of application to respective institute in person.	from 19.09.2018 to 24.09.2018 upto 2.00 pm
3.	Publication of Merit List/Selection List/Wait List on the Notice Board of respective institute and website of respective institute.	24.09.2018 at 5.00 pm
4.	Last date for selected candidates to report respective institute with all original documents and requisite fees for admission.	27.09.2018 upto 5.00 pm
5.	Last date for wait list candidates to report respective institute with all documents and requisite fees for admission.	29.09.2018 upto 5.00 pm
6.	Cut-off-date for MPTH Courses.	30.09.2018
