**AIA-PGET-Ayu-2018**

It is hereby notified for all concerned candidates that the Ministry of AYUSH, New Delhi has informed vide their letter No.R.11011/02/2018/-EP (IM-1) Part-I, dt.26-10-2018 about extension of the Cut-off date for postgraduate ASU&H courses upto 15th Nov.2018 and the Ministry has also directed that the minimum eligibility marks of the entrance test for admission shall be in the percentile instead of percentage. Hence, the minimum marks for open category as 50th percentile i.e. **30 marks** and minimum marks for Constitutional reservation category as 40th percentile i.e. **25.5 marks**.

Therefore, it is hereby notified that for admission to M.D.(Ayu.) / M.S.(Ayu.) and PG Diploma (Ayu), postgraduate course online application forms are invited from eligible candidates of Maharashtra as well as Out of Maharashtra.
