- MAH. B.A./B.Sc.-B. .Ed. Yrs. -CET 2019 shall be conducted only in the ONLINE mode in Multiple sessions, if required, by Competent Authority, using standardized equi-percentile method, will be equating scores of Candidates across sessions.
