- Aspiring candidates should download LL.B-3 Year CET-2019 Information Brochure from website : <http://cetcell.mahacet.org/> <https://www.mahacet.org/cetcell/> for necessary details.
- It is mandatory for all aspiring candidates to **Register & Confirm** the Online Application Form through candidate's login by himself/herself on the website.
- It should be noted that no documents are required to be submitted at the stage of registration for CET. However, Candidates are advised to keep the necessary original documents ready for uploading at the time of Registration for the Centralized Admission Process and verification at the time of Document verification at Facilitation Centre/ SETU Kendra before allotment of Colleges as per the options given by the candidate.
- No Applications are to be sent by Post/Courier. No communication in this regard will be entertained by the CET CELL.
- MAH-LL.B.-3 Yrs. -CET 2019 shall be conducted only in the ONLINE mode in Multiple sessions, if required, by Competent Authority, using standardized equi-percentile method, will be equating scores of Candidates across sessions.
- Aspiring candidates should note that, the On Line Tests are not disclosed to anybody else other than the Candidates only during the CET examination. The Test papers are also not shared with anybody even after the Examination.

- Candidates doing SSC and HSC from CBSE/ICSE/ IB/IGCSE Boards must fill the marks using the certified Conversion Certificate from the Institution and or Board.
